About the Award:

This award is given to a law firm or individual that has shown a special and consistent dedication to Aboriginal people in the field of law. This award recognizes a firm or individual's contribution to the Aboriginal Lawyers Forum (ALF) in working to enhance the stature and influence of Aboriginal people in the legal profession. The recipient will have helped the ALF to address the various issues facing Aboriginal law students and lawyers.

Eligibility:

To be eligible for the award, a nominee must:

- be a resident of BC;
- have attended at least one ALF event;
- not be a current member of the ALF Executive;
- have demonstrated outstanding contribution in the area Aboriginal people in the law, including any or all of the following activities:
 1. supporting the ALF and ALF initiatives;
 2. mentoring and supporting Aboriginal law students and junior lawyers;
 3. working to address the issues facing Aboriginal lawyers, in particular the retention of Aboriginal people in the law; and
 4. working to enhance the stature and influence of Aboriginal people in the legal profession.

There are no posthumous awards.

The 2019 ALF Special Contribution Award will be presented at the 10th Annual ALF Holiday Banquet on November 29, 2018 at the Fairmont Waterfront Hotel in Vancouver, BC.
