Nominations for Election of County Representatives to Provincial Council

Join Provincial Council! As the advisory body to the Board of Directors, members of Provincial Council bring the concerns and interests of lawyers in their region to the attention of the CBABC Board, and bring the latest developments in our profession back to local lawyers.

Each County in the Province is represented on Council. This year there are **six (6)** members to be elected for **three (3)** year terms. **Only CBA members are eligible for nomination and election and if elected, must maintain CBA membership throughout their term of office.** Candidates and nominators must be *practicing* members whose principal place of *business* is in the County, or *non-practicing* members whose *residence* is situated in the County.
