The Award recognizes an exceptional woman who has taken risks, fostered change and ultimately opened doors for women lawyers. In this award we are not only celebrating the woman's distinguished career achievements, but her outstanding contributions to women in the legal profession as a change agent, leader and mentor.

The 2015 recipient of the *WLF Award of Excellence* is the **Honourable Judge Patricia L. Janzen**, Provincial Court of British Columbia.
